1. YOU SHALL REPORT TO THE PROBATION OFFICE AS FOLLOWS: A) MAIL IN PROBATION REPORT CARD BY THE 3rd OF EACH MONTH. B) IN PERSON AS DIRECTED _____
YOU ARE SUBJECT TO RANDOM HOME AND EMPLOYMENT VISITS BY YOUR PROBATION OFFICER.
2. YOU SHALL NOTIFY YOUR PROBATION OFFICER BY PHONE OF ANY CHANGES OF ADDRESS, TELEPHONE NUMBERS, EMPLOYMENT AND JOB CHANGE, PRIOR TO THESE CHANGES.
3. ANY VIOLATION OF LAW IS A VIOLATION OF PROBATION. NO NEW ARRESTS. YOU SHALL INFORM YOUR PROBATION OFFICER OF ANY CONTACT WITH A LAW ENFORCEMENT OFFICER WITHIN 24 HOURS.
4. YOU SHALL ADVISE THE PROBATION OFFICE OF ANY OUT OF STATE TRAVEL AND YOU MAY BE SUBJECT TO EXTRADITION IF ARRESTED WHILE OUT OF THE STATE.
5. YOU WILL BE ON ELECTRONIC MONITORING FOR _____ DAYS AND YOU SHALL OBSERVE ALL PROGRAM RULES. START DATE OF _____ at 9:00 A.M.
6. YOU ARE PROHIBITED FROM CONSUMING AND/OR POSSESSING ALCOHOL AND/OR USING ILLEGAL DRUGS OF ABUSE OR NON PRESCRIBED DRUGS. YOU ARE SUBJECT TO RANDOM ALCOHOL/DRUG TESTING FOR WHICH YOU WILL BE CHARGED A \$5.00 FEE PER TEST. YOU WILL NOT ATTEMPT TO ALTER OR FALSIFY ANY DRUG TESTS. YOU SHALL NOT ENTER INTO ANY LIQUOR ESTABLISHMENT OR ANY RESIDENCE KNOWN FOR SELLING DRUGS.
7. YOU SHALL PAY ALL FINES AND COURT COSTS IN FULL TO THE CLERK OF COURTS OFFICE BY _____ . YOU MUST MAKE A PAYMENT EACH AND EVERY MONTH BY THE END OF THAT MONTH.
8. YOU ARE ORDERED TO MAKE RESTITUTION IN FULL BY _____ , WHICH SHALL BE PAID IN THE PROBATION OFFICE ON A SCHEDULE DETERMINED BY YOUR PROBATION OFFICER.
9. YOU SHALL HAVE A DRUG/ALCOHOL ASSESSMENT AND COUNSELING AS ORDERED. YOU WILL BE SUBJECT TO ANY RECOMMENDATIONS OF THE COUNSELING SERVICE. PROVIDE DOCUMENTATION WITHIN 30 DAYS OF YOUR COURT DATE THEN MONTHLY UNTIL SUCCESSFULLY COMPLETED. SIGN A RELEASE OF INFORMATION SO THE PROBATION OFFICER IS ABLE TO OBTAIN THE DOCUMENTATION REQUESTED.
10. YOU SHALL PERFORM _____ HOURS OF COMMUNITY SERVICE BY _____. THIS COMMUNITY SERVICE WORK IS BEING PERFORMED IN LIEU OF PAYING FINES/COSTS.
11. YOU SHALL NOT HAVE ANY DEADLY WEAPONS OR FIREARMS IN YOUR POSSESSION, IN THE HOME WHICH YOU RESIDE OR ON THE PROPERTY.
12. YOU AGREE TO SEARCH WITHOUT A WARRANT OF YOURSELF, YOUR MOTOR VEHICLE OR YOUR RESIDENCE AT ANY TIME BY A PROBATION OFFICER OR LAW ENFORCEMENT OFFICER.
13. YOU SHALL PAY A PROBATION FEE OF \$50.00 FOR YOUR FIRST MONTH ON SUPERVISION AND A FEE OF \$25.00 FOR EACH ADDITIONAL MONTH. YOU ARE TO PAY THE PROBATION FEE AT THE BEGINNING OF EACH MONTH IN THE PROBATION DEPARTMENT.
14. THE ADDITIONAL ORDER OF _____ IS DEEMED NECESSARY AND SHALL BE OBSERVED.
